

Tuition Policy for 2024-25

Dear Parents,

The actual cost to educate one child at Our Lady of the Lake Catholic School is \$10,500. The OLL Church members help to off-set your child's education. Please consider contributing more towards tuition.

2024-2025 Tuition Grades K-8th:

Tuition \$3400 per student

Full cost \$10,500 per student

Please consider a donation towards the full cost. Any amount above Tuition to help pay the full cost is considered a donation.

A deposit of \$25 per family is required at the time of registration.

Yes, our family can contribute an additional \$_____more per month to help defray the full cost of the education (\$10,500 per child) of our child/ren.

Elementary/Middle School Tuition Policies

Registration

All registration forms including the tuition agreement and the scholarship application forms must be filled out and turned in at the time of the child's registration/enrollment, no later than May 1st.

Payment System

Parents must register prior to your child enrolling at OLL.

Financial Scholarships

Financial scholarship applications are available for all students. Our Lady of the Lake will offer 4 Scholarships for the 2024-25 school year. The Kremer Foundation Scholarship (awarded in October, income-based), Sister Kathleen Brady (must be an active Catholic Family, awarded in January, income-based), St. Mary's of Odanah (awarded in February), The Support A Student (awarded when all other scholarships have been received—needs based).

<u>ALL</u> Scholarship applications are due **no later** than May 1st. A copy of the family's 2023 1040, Year-End W2 or a current paycheck stub is required to begin the application process.

The scholarship awards are based on the school scholarship policies and as funds are available. Late applications will be considered only on a "funds available" basis.

Scholarship/grant monies will be awarded to the family's tuition account <u>after</u> the family has fully paid their portion of tuition.

Scholarship/grant monies awarded for tuition will be forfeited if the family's portion of tuition is not fully paid by May 15th of the school year.

If a family has not fully paid the tuition amount for the current school year before June 30th, the family will not be able to re-enroll the student at Our Lady of the Lake until the balance has been paid in full. Unique and special circumstances for school families may be considered on a case-by-case basis and taken into consideration by the principal and the pastor.

The actual cost to educate one child at Our Lady of the Lake Catholic School is \$10,500. The parishioners of OLL Church help support the cost per student as one of the primary missions of the church.

Those families that may be able to donate more towards their child's education can do so with a tax-deductible donation.
